

Deep State Coup: Special Prosecutor Mueller Packs Team With Obama, Clinton Loyalists

There is no question that Comey is "substantially involved," and there is no question that Comey and Mueller have both a personal and political relationship.

As is the case with all things left-wing, the news actually got worse overnight. According [to Lifezette](#), Mueller is packing his witch hunt with Democrat donors, specifically donors to Barack Obama and Hillary Clinton. Worse, one of Mueller's picks was a Clinton Foundation lawyer:

Four top lawyers hired by Mueller have contributed tens of thousands of dollars over the years to the Democratic Party and Democratic candidates, including former President Barack Obama and President Donald Trump's 2016 opponent, Hillary Clinton.

One of the hires, Jeannie Rhee, also worked as a lawyer for the Clinton Foundation and helped persuade a federal judge to block a conservative activist's attempts to force Bill and Hillary Clinton to answer questions under oath about operations of the family-run charity.

Another lawyer, James Quarles, donated thousands of dollars to Democrats, including \$2,700 to Hillary just last year. Andrew Weissmann donated \$2,300 to Obama in 2008 and \$2,600 to the DNC in 2006. Michael Dreeben donated \$250 to Hillary in 2006.

Of the tens of thousands of dollars these four have donated to Democrats and Democrat causes, only two donations could be found to Republicans, one for \$250 a full 11 years ago and a \$2500 donation to Rep. Jason Chaffetz in 2015.

After nearly a year of billions of corporate media dollars being spent to look into it; after nearly a year of the entire infrastructure of the federal government looking into it; after months of the Obama administration's secret and illegal spying — there is absolutely no evidence of any collusion between Trump and Russia.

Moreover, even if you interpret what we do know in the worst possible way, Trump is in no way guilty of anything even close to obstruction of justice.

So what exactly is it that Mueller is investigating?

Nothing.

Nevertheless, Mueller's investigation hasn't even gotten started and already it is illegitimate, thoroughly compromised, and in violation of government ethics rules.
